- You have the right to hire a lawyer to represent you.

- You have the right to remain silent.
- You are not required to make a statement, and any statement you make can and may be used against you in court.
- You have the right to stop any interview or questioning at any time.
- You have the right to have examining trial (felonies only).
- You have the right to legal representation by a lawyer if you cannot afford a Lawyer. *

*** THE MAGISTRATE SHALL ENSURE THAT THE PERSON IS INFORMED OF THE FOLLOWING PROCEDURES:**

- a. An application for a court appointed lawyer must be completed to determine if you qualify for a lawyer to be paid by Comal County;
- b. Reasonable assistance will be provided to you when filling out the application for a court appointed lawyer, if needed;
- c. A financial affidavit must be signed and may be additionally considered for an appropriate Bail Bond decision.
- d. An affidavit is a written or printed declaration of facts made voluntarily and confirmed by oath before a person having authority to administer an oath. The financial affidavit that we will go through helps to determine whether you have the necessary finances to hire your own private lawyer;
- e. If you meet indigence standards, you will qualify to have a lawyer represent you who will be paid by Comal County;
- f. You should expect that your lawyer will try to contact you by the end of the first working day after appointment and to interview you as soon as possible after appointment. If the appointment is made when you are before the court, you will be given the lawyer's name, address, and phone number.

If you are not a United States citizen and you have been arrested or detained, you may be entitled to have us notify your country's consular representatives here in the United States. Do you want us to notify your country's consular officials? No. Yes. If you responded "Yes", what country? _____

If you are a citizen of a country that requires us to notify your country's consular representative, we shall notify them as soon as possible.

Bail and conditions are set pursuant to C.C.P. Art. 17.021, 17.15, 17.20, and 17.21, including consideration of criminal history and the Public Safety Report System.
