ADMONISHMENTS AND WAIVER BY DEFENDANT

COMES NOW the Defendant in open Court in the above entitled and numbered cause and makes the following voluntary statements:

- 1. THAT I understand the nature of the charges against me.
- 2. THAT I understand I have the right to be represented by legal counsel of my own choice if I am able to employ counsel and if I am too poor to employ counsel, the Court will appoint an attorney to represent me.
- 3. THAT I understand I have the right to a trial by jury whether I plead "guilty", "not guilty" or "no contest".
- 4. THAT the Court has warned me of the consequences of a plea of quilty, including the range of punishment.
- 5. THAT I have the right to remain silent but if I choose not to remain silent anything I say can be used against me.
- 6. THAT I have the right to be confronted with the witnesses against me whether I have a trial before the Court or the jury.

HOWEVER, I DESIRE TO WAIVE AND DO GIVE UP THE FOLLOWING RIGHTS:

WAIVE the right to be represented by legal counsel.

WAIVE the reading of the information and arraignment.

WAIVE the right of trial by jury and request the consent and approval of the Court and of the attorney for the State to such waiver.

WAIVE my right to remain silent and state that I will take the witness stand knowing anything I may say can be used against me and my testimony is confession of my guilt.

WAIVE the right to be confronted with the witnesses against me and request the approval of the Court to the stipulation of the evidence by my waiving the appearance confrontation and cross examination of witnesses, and by my further consenting to the introduction of testimony and evidenced by stipulation into the record by the attorney for the State by oral stipulations of by affidavit, or by written statements of witnesses and any other documentary evidence.

WAIVE the 10-day period for trial after the appointment of counsel.

WAIVE the time provided by law for filing a motion for new trial or motion in arrest of judgment and I request that sentence by pronounced this day.

I DO FURTHER admit and judicially confess that I knowingly, intentionally and unlawfully committed the acts alleged in the information in this cause at the time and place and in the manner alleged and that I AM IN FACT GUILTY of the offense of and that I enter my free and
