## **Hourly Fee Schedule for Non-Trial Dispositions in Felony Cases**

## (Plea and Sentence; Discovery and Dismissal; & Motions to Adjudicate or Revoke Probation)

Counsel appointed to  $2^{nd}$  Degree ("B" List) Cases and  $1^{st}$  Degree ("A" List) cases may bill on an hourly basis for services rendered. If counsel elects to bill on an hourly basis, counsel shall submit itemized invoices reflecting the date, service performed, and time expended to the nearest  $1/10^{th}$  of an hour, based on the fee schedule below, and up to the maximum cap.

\*\*Fees in excess of the cap must be specifically approved by the court in advance of being incurred. \*\*

State Jail and 3<sup>rd</sup> Degree cases shall ordinarily be paid based on the fixed fee schedule above. In limited circumstances, for non-standard cases, the Court may authorize payment based on hourly billing in advance of costs being incurred.
